Note that across repeated play "**BBO Bridge Master**" may change some Hands in given lessons. Esther may have altered some cards in some Hands.

Dealer: **SOUTH**

NORTH (5)

**S:** 4 2  
**H:** 3 2  
**D:** A T 2  
**C:** J T 9 8 7 6

WEST (7)

**S:** Q J T 9 8 6  
**H:** 5 4  
**D:** 6 5 4  
**C:** A 4

EAST (7)

**S:** 7 5 3  
**H:** Q 8 7 6  
**D:** Q 9 8 7  
**C:** K 5

SOUTH (21)

**S:** A K  
**H:** A K J T 9  
**D:** K J 4  
**C:** Q 3 2

**Bidding**

SOUTH	WEST	NORTH	EAST
2NT	PASS	3NT	PASS
PASS	PASS		

On Trick #1 WEST leads the Spade Queen thus promising "length" in Spades and the "lower" Spade "touching Honors".

1. After the NORTH Dummy is exposed how many cards can Declarer SOUTH see that N/S together hold in each Suit?
2. Is there a "Danger Suit"?
