The "**BBO Bridge Master**" website allows you to declare your skill level, then shows a series of Hands and announces the final contract, each of which you then play as Declarer. At the end of play you can then request a solution in which the optimal "Line of Play" is discussed step by step. The present "Esther Bridge 'Pop' Quiz" question is drawn from "**BBO Bridge Master**" Level-3 **Lesson B-15**. Note that across repeated play "**BBO Bridge Master**" may change some Hands in given lessons. Esther may have altered some cards in some Hands.

BBO Bridge Master Level 3 Lesson B-15

Dealer: **SOUTH**

NORTH (10)

S: 3 2
H: A 5
D: 4 3 2
C: A Q 9 8 7 6

WEST (8)

S: Q J T 9 8
H: 7 6
D: A 5
C: J 4 3 2

EAST (6)

S: 7 6 5 4
H: Q J T 9 8
D: K 6
C: T 5

SOUTH (16)

S: A K
H: K 4 3 2
D: Q J T 9 8 7
C: K

Bidding

SOUTH	WEST	NORTH	EAST
1 D	PASS	2 C	PASS
2 H	PASS	3 C	PASS
3 NT	PASS	PASS	PASS

On Tricks #1 WEST leads his Spade Queen and Declarer SOUTH "wins" in his "closed" (hidden) Hand.

1. After the NORTH Dummy is exposed how many "winners" can Declarer SOUTH see?
2. Is there a "Danger Suit" that Declarer SOUTH should see?
