Dealer: **SOUTH**

NORTH (12)

S: A 4 2
H: 6 5 4 3 2
D: A 2
C: A 3 2

WEST (4)

S: T 7 5 3
H: T 9 8
D: K J 3
C: T 9 8

EAST (3)

S: 9 8 6
H: Q J 7
D: 6 5 4
C: 7 6 5 4

SOUTH (21)

S: K Q J
H: A K
D: Q T 9 8 7
C: K Q J

Bidding

SOUTH	WEST	NORTH	EAST
2 NT	PASS	6 NT	PASS
PASS	PASS		

On Trick #1 WEST leads the Club Ten thus "promising" "touching" Club cards.

1. Once the NORTH Dummy is exposed what "winners" can Declarer SOUTH see?
2. Where can Declarer SOUTH try to develop the 3 additional Tricks that N/S **must** "win" in order to "make" SOUTH's 6**NT** contract?
